The calendar says it is June, which often suggests a winding down – heading into a season of leisure and vacations, time at the shore or in the mountains, but the activity level at Zwingli looks more like September already. Granted, our Sunday School classes are going on hiatus for the next couple months, Confirmation has concluded, and the choir has some time off, but there's an awful lot still going on and picking up speed. You'll see a number of articles on the next pages that tell you about many of these events, but others are happening behind the scenes.

We are once again sponsoring a Concert in the Park. We are hoping for better weather this year when we "host" on June 9<sup>th</sup>. If you are able to attend, please wear a Zwingli shirt or hat to help make our presence visible. That will be followed the next Sunday morning by our Souderton Alive Worship in the Park with six other Souderton churches, where our own Pastor Butch will be bringing the message. This service was enjoyed last year by over 700 worshippers. You won't want to miss it.

One of the additional, *very visible* events coming up is our hosting of the Community Vacation Bible Camp with 5 other area churches from July 29 to August 2. Registration has just opened up, and we are anxious to see how close we come to filling our 120 child maximum. That's a LOT of little people, requiring a LOT of support and lots of donations. We'll keep you informed about needs.

The energy and enthusiasm that are contributing to our VBC involvement is also spurring new ideas from our Educators. With attendance in our children's classes increasing on Sunday mornings, it is time to consider some changes. First, instead of splitting sometimes 25 children into just 2 age groups (3 year olds to 1<sup>st</sup> grade and 2<sup>nd</sup> grade to 5<sup>th</sup> grade), we really need to break into 3 age groups and keep our class sizes more manageable. Also, it's no surprise that all of our children do better when there is some consistency – seeing the same teachers on a regular basis. That became very evident when our littlest ones got to see Corynne in the nursery every week. It's a much better way to minister to our children and young families. So we are looking at different models – perhaps team teaching (so no one feels tied to every week, but the kids will always know to expect one of their two team teachers to be there), which of course means looking for more commitment from more volunteers.

Another behind-the-scenes summer focus is looking at our music ministry and considering various ways to make worship more welcoming to our children and young families. Zwingli is so blessed to have the number of families with children that we do. It is our responsibility to make sure they experience God's love poured out on them through us – and that might mean singing some different kinds of songs, ignoring a bit of wiggling or giggling, or maybe even finding a different seat because kids should really sit close enough to the front to see what's going on and feel connected – not restricted to the back rows where all they see is the backs of peoples' heads.

There have been several questionnaires presented recently (including on in this mailing). It's a great sign that we are paying attention to new ideas and what works (or doesn't). The Shepherds are considering offering a Women's retreat in the fall, the Educators want our Intergenerational Gatherings to be as effective and well attended as possible, Adult Electives want feedback on worthwhile topics. Those of you who have been responsible for programs over the years know how daunting a task it can be to introduce something new. At a PSEC workshop a while ago one church explained their approach is to try a "friendly experiment" that gave opportunities to try on new things without everyone getting all upset. I encourage you this summer to lend support and keep in prayer not only the busy and visible ministries going on, but also those in our church who are working diligently in preparation for exciting ways of sharing God's love with each other and those yet to arrive. Blessings!


Make this craft to show appreciation for your dad or another special man.

# ASSOCIATE PASTOR SEARCH COMMITTEE UPDATE

The Search Committee continues to be engaged in the process of receiving profiles, identifying potential candidates and conducting interviews. We have received six profiles thus far, which is less than hoped. Offering a part-time (3/4 time) position certainly affects the number of potential candidates, but the number of profiles coming into the Pennsylvania Southeast Conference (and other conferences) overall is in decline. Even so,

the committee identified three possible candidates and have conducted first interviews. We are following up with one candidate for a second interview, which we trust will help with the discernment process. The committee will continue to receive profiles until a decision is made to pass along a candidate to the Elders and then to Council for approval. Once the steps for approval are made, the candidate will be invited to offer a trial sermon and meet members of the congregation. A vote will be taken that day by the congregation regarding a call to the candidate to serve Zwingli UCC as Associate Pastor.

The opening article in last month's mailing (and one in January) offered a glimpse into the meeting of the 32nd General Synod of the United Church of Christ, to be held in Milwaukee, Wisconsin. In the past few weeks, committee assignments have been made for the delegates, and I've been assigned to a committee that will discuss a particular resolution and discern whether it should be brought to the floor for a vote as is, if changes/addendums should be

made, or if the resolution should be tabled. Overall, the number of resolutions to be considered, along with other business, is 23 (yes – 23!). Though the official dates for the Synod are June 21-25, I will arrive in Milwaukee on the 20<sup>th</sup> (initial meeting of delegates will be early in the day on the 21<sup>st</sup>) and will leave the 26<sup>th</sup>. Sally will be accompanying me and we will wrap vacation time around Synod, leaving on June 18<sup>th</sup> and returning July 5<sup>th</sup>. # Should I or Should I Not Vaccinate My Children? Kristie Lowery, Faith Christian Community Nurse

"40At sunset, the people brought to Jesus all who had various kinds of sickness, and laying his hands on each one, he healed them". Luke 4:40

Recently, news reports have focused on the measles and mumps outbreaks occurring in Pennsylvania. When I was growing up, measles and mumps were a common occurrence and I can remember having both. But as vaccines were developed and initiated, these contagious diseases have been almost eliminated. So why are we seeing this sudden outbreak?

The Centers for Disease Control and Prevention (CDC) issued an informative bulletin titled, Vaccines and Immunizations -What Would Happen If We Stopped Vaccinations? I am including excerpts of the article to assist in explaining the reason why vaccines are needed to prevent the spread of these contagious diseases. "Before the middle of the last century, diseases like whooping cough, polio, measles, Hemophilus influenzae, and rubella struck hundreds of thousands of infants, children and adults in the United States. Nearly everyone in the U.S. got measles before there was a vaccine, and hundreds died from it each year. As

vaccines were developed and became widely used, rates of these diseases declined until today most of them are nearly gone from our country. Prior to this recent outbreak, some doctors have never seen a case of measles. More than 15,000 Americans died from diphtheria in 1921. before there was a vaccine. Only two cases of diphtheria have been reported to the CDC between 2004 and 2014. An epidemic of rubella (German measles) in 1964-65 infected 12 ½ million Americans. killed 2,000 babies, and caused 11,000 miscarriages. Since 2012, 15 cases of rubella were reported to the CDC. Given successes like these, it might seem reasonable to ask, "Why should we keep vaccinating against diseases that we will probably never see. The reason is that vaccines don't just protect yourself.

Most vaccine-preventable diseases are spread from person to person. If one person in a community gets an infectious disease, he can spread it to others who are not immune. But a person who is immune to a disease because she has been vaccinated can't get that disease and can't spread it to others. The more people who are vaccinated, the fewer opportunities a disease has to spread. If one or two cases of disease are introduced into a community where most people are not vaccinated, outbreaks will occur. If vaccination rates drop to low levels nationally, diseases could become as common as they were before vaccines. The chances of a child getting a case of measles, chickenpox, or whooping cough might be quite low. But vaccinations are not just for protecting ourselves, and are not just for today. They also protect the people around us. And they also protect our children's children and their children by keeping diseases that we have almost defeated from making a comeback. What would happen if we stopped

vaccinations? We could find ourselves battling epidemics of disease we thought had been conquered decades ago.

The recent reports of measles and mumps outbreaks reinforces the importance of making sure children receive the vaccines needed to increase their immunity to fight contagious diseases. The what if's that can happen without vaccines being administered is far more critical compared to the inconvenience of getting the vaccines.

# Faithful Stewards: Required Minimum Distributions for Zwingli

Trying to decipher the tax codes and regulations can be confusing and mind bogaling. What can I deduct, what must be reported, what will be taxed or not taxed? Trying to keep up with the regulations often causes one to consider consulting with a third party for intervention and financial advice. Over the last few years, regulations for Required Minimum Distributions (RMD) have changed, often at the last minute, for tax reporting requirements. However, the Protecting Americans from Tax Hikes (PATH) Act of 2015 established that the Qualified Charitable Distribution (QCD) rules were permanent and there is no anticipation that the rules will be changing annually. This has made it easier to engage in proactive charitable giving that helps to minimize the tax crunch of an IRA's Required Minimum Distribution obligations that need to occur beginning at age 70 ½. A qualified charitable distribution generally is a nontaxable distribution made directly by the trustee of your IRA to an organization eligible to receive tax deductible contributions. The benefit of doing a QCD from an IRA is that the distribution comes out of the IRA without any of the tax consequences that would otherwise apply to a withdrawal. If the distribution check was made out to the IRA owner, and then given to the charity, it is included as income for the IRA owner and may be deducted if the taxpayer is itemizing deductions. Designating the check to be written for a charity will not count as taxable income for the IRA owner. Under a QCD, the charitable

contribution made from the IRA is not included in the gross income of the IRA owner. The owner cannot take a deduction for the contribution, but it's not included in the income.

The QCD counts toward the required minimum distribution (RMD) for the year. RMD's can increase gross income, which in turn can increase income taxes. As a taxpayer, you can meet your RMD obligations and make a charitable contribution with the same action. Obtaining the tax benefits for transferring a charitable donation from an IRA to a charity requires meeting very specific requirements, which are listed below:

- The IRA owner must be at least age 70 ½ on the day of distribution to the charity.
- Maximum dollar amount of a QCD for any individual from the IRA is \$100,000/year. A married couple may each give up to \$100,000 from each of their respective IRA's.
- The charitable contribution must be made directly from the IRA owner to the trustee of the charity.
- The distribution should be given to the charity before December 31, to assure that the donation is satisfied for the current tax year.
- A QCD can be made only from an IRA.
- The IRA owner cannot receive any benefit from the charitable contribution. A QCD can be used to satisfy a pledge made by the IRA owner to the charity.
- The IRA owner will need documentation from the charity acknowledging the amount and date of the contribution.
- QCD's can be made only to public charities that are eligible for charitable contribution deductions

- under the IRS rules. Zwingli UCC is considered an eligible charity.
- If you make a tax-free transfer from your IRA to charity, you cannot deduct that money as a charitable contribution.

If you find yourself meeting the age requirements (70 ½) for a required minimum distribution, and if you want to avoid paying taxes on the RMD, consider a qualified charitable distribution to Zwingli United Church of Christ. Direct your financial advisor to assign the distribution specifically to Zwingli and make sure it is received by the church before the end of the current tax year. The church will provide you with a letter acknowledging receipt of the payment. Making a qualified charitable distribution to Zwingli is a win win for you and the church. The church will benefit from your financial support and you will avoid paying income tax on your required minimal distribution.




#### STRENGTHEN THE CHURCH OFFERING
